THE MARK CONSISTS OF AN EXTENDED HORIZONTAL BLOCK LINE CONNECTED AT THE LEFT EDGE TO A BLOCK VERTICAL LINE CURVING DOWNWARDS TO THE RIGHT WITH A SHORT HORIZONTAL BLOCK LINE EXTENDING TO THE RIGHT FROM THE MIDDLE OF THE CURVE REPRESENTING AN UPPER CASE LETTER "F", UPPER CASE LETTERS "R" AND "P" AND A BLOCK VERTICAL LINE EXTENDING DOWNWARDS AND CURVING TO THE LEFT REPRESENTING AN UPPER CASE LETTER "I", ALL SURROUNDED BY A LINE DRAWN IN THE SHAPE OF A SHIELD WITH THREE PEAKS AT THE TOP, ONE AT EACH END AND ONE IN THE MIDDLE AND A POINT AT THE BOTTOM. IN ADDITION, THE UPPER CASE LETTERS "C E R T I F I E D" CURVING UPWARDS, LOCATED ADJACENT TO AND TO THE RIGHT OF THE SHIELD.
